**SECTION B CITYWIDETECH'S TERMS AND CONDITIONS OF TRADE**

1. General  
 "Products" means the products supplied by CITYWIDE TECH to the Customer.  
 "Customer" means the company or entity purchasing the Products and includes the applicant submitting this Application For Credit.
2. Terms and Credit  
 CITYWIDETECH's normal terms are 20<sup>TH</sup> of the following month.  
 A credit facility may be available on application.  
 CITYWIDETECH reserves the right at all times without notice and at its sole discretion to:
  - (a) refuse to grant credit;
  - (b) suspend, withdraw or discontinue credit;
  - (c) require fresh application/personal guarantee(s) to be submitted;
  - (d) selectively withdraw any discount offerings;
  - (e) charge interest on any balance remaining outstanding after the due date at a rate equivalent to the prevailing bank interest rate on unsecured loans.
 Credit limits are established by CITYWIDETECH and confirmed in writing at the time of opening a trading account. For the avoidance of doubt, the credit limits approved may not necessarily be the credit limits requested by the Customer and the credit limits may be adjusted from time to time at CITYWIDETECH's sole discretion.
3. CITYWIDETECH will use its best endeavors to keep its customers informed of the current prices for the Products and notify the customer of any changes or variations to its current price list. For the avoidance of doubt and notwithstanding anything to the contrary, CITYWIDETECH may alter its prices without prior notice.
4. Stock Items  
 All Products are subject to availability.
5. Freight  
 All prices quoted in the published price list do not include freight. These will show separately on official CITYWIDETECH invoices.<sup>7</sup>  
Retention of Title and Risk (Personal Property Securities Act 1999)  
 Title in any Products supplied by CITYWIDETECH passes to the Customer only when the Customer has made payment in full for all Products provided by CITYWIDETECH and of all other sums due to CITYWIDETECH by the Customer on any account whatsoever. Until all sums due to CITYWIDETECH by the customer have been paid in full, CITYWIDETECH has a security interest in all products. For the avoidance of doubt, this clause shall also apply where payments are made for the purpose of settlement of specially designated claims.  
 If the Products are attached, fixed, or incorporated into any property of the Customer, by way of any manufacturing or assembly process by the Customer or any third party, title in the Products shall remain with CITYWIDETECH until the Customer has made payment for all products, and where those Products are mixed with other property so as to be part of or a constituent of any new Products, title to these new products shall deemed to be assigned to CITYWIDETECH as security for the full satisfaction by the Customer of the full amount owing between CITYWIDETECH and Customer.  
 The Customer gives irrevocable authority to CITYWIDETECH to enter any premises occupied by the Customer or on which Products are situated at any reasonable time after default by the Customer or before default if CITYWIDETECH believes a default is likely and to remove and repossess any Products and any other property to which Products are attached or in which Products are incorporated. CITYWIDETECH shall not be liable for any costs, damages, expenses or losses incurred by the Customer or any third party as a result of this action, nor liable in contract or in tort or otherwise in any way whatsoever unless by statute such liability cannot be excluded. CITYWIDETECH may either resell any repossessed Products and credit the Customer's account with the net proceeds of sale (after deduction of all repossession, storage, selling and other costs) or may retain any repossessed Products and credit the Customer's account with the invoice value thereof less such sum as CITYWIDETECH reasonably determines on account of wear and tear, depreciation, obsolescence, loss or profit and costs.  
 The following shall constitute defaults by the Customer:
  - (a) Non payment of any sum by the due date.
  - (b) The Customer intimates that it will not pay any sum by the due date.
  - (c) Any Products are seized by any other creditor of the Customer or any other creditor intimates that it intends to seize Products.
  - (d) Any Products in the possession of the Customer are materially damaged while any sum due from the Customer to CITYWIDETECH remains unpaid.
  - (e) The Customer is bankrupted or put into liquidation or a receiver is appointed to any the Customer's assets or a landlord disdains against any of the Customer's assets.
  - (f) A Court judgement is entered against the Customer and remains unsatisfied for seven days.
  - (g) Any material adverse change in the financial position of the Customer.
 If the Credit Repossession Act applies to any transaction between the Customer and CITYWIDETECH, the Customer has the right provided in that Act despite anything contained in these terms and conditions of trade. CITYWIDETECH  
 Until property passes to the Customer:
  - (a) The Customer shall hold the Products as bailee for CITYWIDETECH; and
  - (b) The Customer irrevocably authorises CITYWIDETECH its servants or agents to enter upon the Customer's premises at anytime to all things necessary (including opening up any assembled PC or peripheral unit to inspect and to remove therefrom any Products attached to or incorporated in such assembled PC or peripheral unit) in order to take possession of the Products.
 Risk in the Products shall pass at the time of delivery and the Customer shall insure and keep insured the Products.
